The business will:  Implement scheduling to limit exposure to large crowds and rush hours where appropriate. Revise pick-up and drop-off collection points and procedures with signage and marking. Where possible and safe, have single workers load or unload vehicles. Minimise unnecessary contact at gatehouse security, yard and warehouse, for example non-contact deliveries where the nature of the product allows for the use of electronic pre-booking. Maximise the use of electronic paperwork where possible and review procedures to enable safe exchange of paper copies where needed, for example required transport documents. Enable drivers to access welfare facilities when required and consistent with other guidance. If possible, make arrangements with clients prior to the delivery to leave the parcel/package/goods in a safe location without coming into contact with anyone. Also, if possible, we will try to avoid going inside buildings or enclosed premises. Instead, arrange the delivery by the outside door/gate. Instruct drivers to remain mindful when entering the buildings/premises to avoid any physical contact with individuals (e.g. handshakes, patting shoulders, etc.) and to keep contact with objects (e.g. door handles, handrails, etc.) to a minimum.
